All sports and clubs with a Booster support structure that requires fees to be paid, will work to assess the impact of their fees as barriers to participation. Fund Raising will be suggested and supported to pay these fees. Also reporting structure being established for ASB oversight of Booster clubs at KR. 3. A benefits list of everything a student/family can get if they qualify for HB 1660. Also let families know of FERPA protections that will keep others from knowing their status. 4. We will reach out in as many languages as possible. We plan to have help at Open House and other events with stations to assist parents/families in filling out paperwork. 5.
